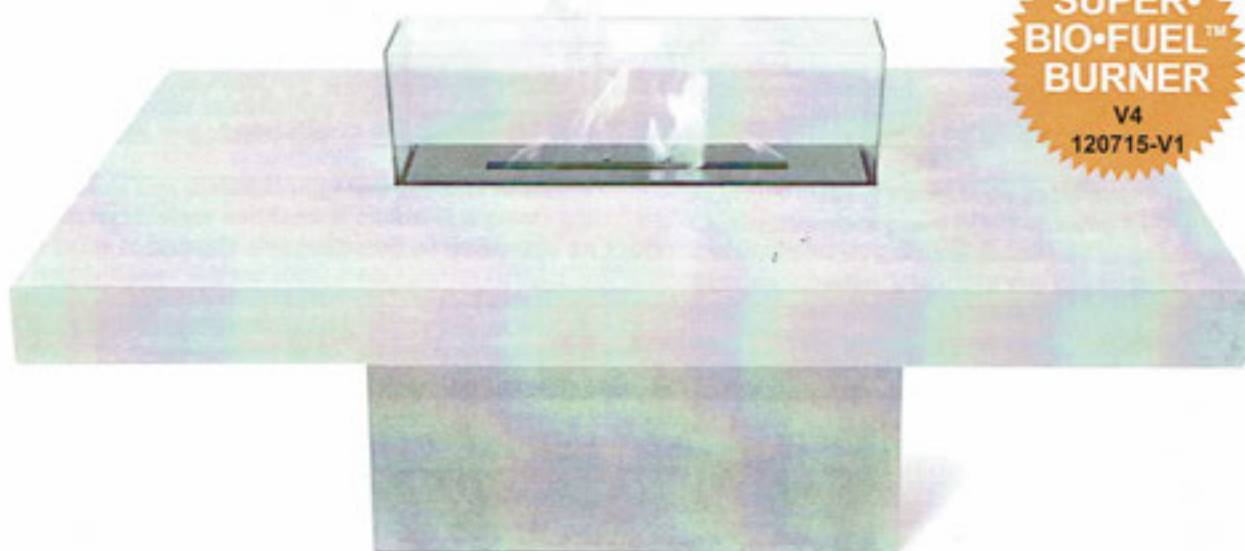

YOU MUST READ & UNDERSTAND ALL THESE INSTRUCTIONS BEFORE YOU ASSEMBLE AND OR OPERATE THIS SUPER•BIO•FUEL™ BURNER. If you do not UNDERSTAND any part of these instructions DO NOT ASSEMBLE OR OPERATE the SUPER•BIO•FUEL™ Burner.



If the information and WARNINGS in this manual are not followed exactly, a fire or explosion may result causing property damage, SEVERE BURNS or DEATH.



NEVER allow anyone to operate this SUPER•BIO•FUEL™ Burner without them fully reading and understanding all warnings, dangers & operations.



NEVER LEAVE SUPER•BIO•FUEL™ Burner UNATTENDED AT ANY TIME. Doing so is extremely dangerous. Never leave any fire unattended.



MAKE SURE you assemble product as specified in this Owner's Manual.



ONLY use a long-stemmed kitchen / BBQ Butane lighter to light burner. NEVER use a cigarette lighter or matches to light fire.



Only use specified SUPER•BIO•FUEL™ as specified in this Owner's Manual – NEVER use any other type of fuel including ETHANOL fuels. We recommend that you use NO more than 1.0 liters of Super•Bio•Fuel™ for each burning session. Fill only to the max fuel reservoir indicator. Do not store any fuel near burner at any time. Failure to follow manufacturer's directions and owner manual's instructions will void any liability and warranty.



Do not allow the 'Wicks' in the SUPER.BIO.FUEL™ Burner to become wet with any other liquid other than the SUPER.BIO.FUEL™. When not using the burner, safely store it empty (i.e. free of fuel) and inside a protected and ventilated space well away from children or pets.



WHAT TO DO IN THE EVENT OF UNCONTROLLABLE FIRE:

Fire extinguisher – MAKE SURE YOU USE CORRECT FIRE EXTINGUISHER for the specified fuel. Do NOT place yourself in harm's way. Notify others and evacuate premises immediately. Call Fire department / Emergency Services.



Never allow children under the age of 18 to handle or operate burner or SUPER•BIO•FUEL™ at any time. Keep all fuel secure and well away from children and any pets.



NEVER consume / use non prescription or psychological/recreational drugs or alcohol prior to and or during the operation of the SUPER.BIO.FUEL™ Burner. NOTE: The use and installation of this product must conform to local, state and federal codes. It is your responsibility to check that this burner conforms to Fire & Safety codes in your local area.

NOTICE: BUYER ASSUMES ALL RESPONSIBILITY FOR SAFETY AND USE THAT IS NOT IN ACCORDANCE WITH INSTRUCTIONS AND WARNINGS

Minimum Clearance From Unit to Combustible Construction: 72" (182.9cm) from the top; 48" (121.9cm) from all sides and back. **DO NOT** locate this appliance under overhead, unprotected combustible surfaces.

- Improper installation, adjustment, alteration, service or maintenance can cause injury or property damage. Read the installation, operation and maintenance instructions thoroughly **BEFORE** INSTALLING the SUPER•BIO•FUEL™ Burner
- Keep these instructions for future reference. If you are installing this unit for someone else, give this manual to him or her to read and keep for future reference.
- The SUPER•BIO•FUEL™ Burner shall **ONLY** be used in conjunction the Perpetual Collection Zanzibar Table table it is shipped with (replacement burner must also **ONLY** be used with original table(s)). This burner is **NOT INTENDED** to be used with any other table other than what is shown in this User Manual. Should this Burner be used with any other table (other than defined in this User Manual) then User / Buyer assumes all responsibilities and consequences of his/her actions.
- Never **LEAVE** this SUPER•BIO•FUEL™ Burner burning / unattended without a responsible adult being in permanent attendance.
- Always discuss with all children the importance of fire safety and the dangers associated with fire and extreme heat generated from the SUPER•BIO•FUEL™ Burner (and the Ceram glass guard) – The SUPER•BIO•FUEL™ Burner and Ceram fire glass guard become hot very quickly once the SUPER•BIO•FUEL™ Burner is lit.
- NEVER permit children or pets to play on, near or around the table(s), the SUPER•BIO•FUEL™ Burner and the Ceram glass fire guard at any time.
- **MAKE SURE** once the SUPER•BIO•FUEL™ Burner has been extinguished and the SUPER•BIO•FUEL™ Burner vents have been closed that children and pets are not permitted within the vicinity of the table, SUPER•BIO•FUEL™ Burner and Ceram fire glass guard for **AT LEAST 1 hour (60 minutes)**.
- This SUPER•BIO•FUEL™ Burner and Ceram fire glass guard is **NOT** to be touched or operated **AT ANY TIME** by children. Young children need to be very closely supervised when in the vicinity of this SUPER•BIO•FUEL™ Burner and Ceram fire glass guard. **NEVER** leave an unsupervised child alone near a lit burner.
- **ALWAYS** inspect the SUPER•BIO•FUEL™ Burner and Ceram fire glass guard **BEFORE** using it – The SUPER•BIO•FUEL™ Burner must always be in good condition (No dents, holes, leaks and any other damage that might compromise the safe use of the burner – if in doubt, do not use it. Instead contact your retailer or the company that sold you the product and seek assistance). Check for debris and any other foreign materials that may have lodged themselves into the burner vent area and **OR** in the fuel tank if any part of the fuel tank has been left open and fully exposed. **ALWAYS** check the Ceram fire glass guard for chips, cracks or breaks **EVERY TIME** before you light the SUPER•BIO•FUEL™ Burner. **NEVER** use the Burner and / or the Ceram fire glass guard if any part is in any way damaged or deteriorated.
- If the SUPER•BIO•FUEL™ Burner or Ceram fire glass guard appears flawed, damaged or is in a state of deterioration it must be replaced before the SUPER•BIO•FUEL™ Burner is used. If you suspect that the SUPER•BIO•FUEL™ Burner or Ceram fire glass guard is compromised in any way do **NOT** use or light the SUPER•BIO•FUEL™ Burner at all. A SUPER•BIO•FUEL™ Burner and Ceram fire glass guard specified by the manufacturer can only replace the SUPER•BIO•FUEL™ Burner and Ceram fire glass guard that you purchase or is shipped to you. Contact the original store or design firm from whom you purchased this product.
- Do **NOT** operate, light or use the SUPER•BIO•FUEL™ within 6 feet of combustible walls, structures or buildings.
- Storage of the Zanzibar table with the SUPER•BIO•FUEL™ Burner is permissible only when the SUPER•BIO•FUEL™ Burner is not in use and there is **NO** SUPER•BIO•FUEL™ liquid stored in the SUPER•BIO•FUEL™ reservoir tank.
- Do **NOT** place any combustible materials (including but not limited to table decorations) within 40" (1.0M) of the liquid SUPER•BIO•FUEL™ Burner. Keep the SUPER•BIO•FUEL™ Burner and table at least 80" (2.0M) away from curtains, tents or draperies.

DANGERS and WARNINGS: FOR YOUR SAFETY

- **The SUPER•BIO•FUEL™ Burner must use ONLY the specified and recommended SUPER•BIO•FUEL™ DO NOT USE ANY OTHER TYPE OF FUEL – NOT ONLY IS THIS EXTREMELY DANGEROUS AND HAZARDOUS, YOU SHOULD KNOW AND UNDERSTAND THAT THIS BURNER IS NOT DESIGNED FOR STANDARD ETHANOL FUEL OR ANY OTHER TYPE OF LIQUID OR GEL FIRE FUEL. FAILURE TO FOLLOW THIS INSTRUCTION COULD LEAD TO AN EXPLOSION, UNCONTROLLABLE FIRE, SEVERE BURNS AND OR DEATH – PLEASE BE VERY CAREFUL AT ALL TIMES.**
- Do NOT burn solid fuels such as: paper, wood, charcoal briquettes, lump charcoal, driftwood, trash, leaves, cardboard, plywood or stained or pressure treated wood with this SUPER•BIO•FUEL™ Burner.
- Do NOT toast or cook any type of food (e.g. Marshmallows) over a lit SUPER•BIO•FUEL™ Burner. Fuel is a toxic liquid, cooking or toasting food over a lit SUPER•BIO•FUEL™ Burner can result in the food dropping or falling into the SUPER•BIO•FUEL™ Burner. This may lead to the person cooking to want to lean over burner or retrieve the food – Do NOT allow this action – THIS IS DANGEROUS.
- DO NOT store any combustible materials in the table base enclosure.
- The use of alcohol, prescription or non-prescription drugs may impair an individual's ability to properly assemble or safely operate this SUPER•BIO•FUEL™ Burner. Do Not serve or consume high alcohol beverages (i.e. alcoholic drinks that contain 70 percent alcohol (140 proof) e.g. Absinthe and or Bacardi 151). Alcoholic drinks that contain a high alcoholic content level are flammable and should not be served near any open flame / burner and specifically not within 6 feet (72" inches) of the SUPER•BIO•FUEL™ Burner. The Burner could be a source of ignition for the alcoholic drink.
- DO NOT operate the SUPER•BIO•FUEL™ Burner in an explosive atmosphere. Keep the SUPER•BIO•FUEL™ Burner / table clear and free of combustible materials, gasoline and other flammable vapors and liquids – this includes ethanol and or any other flammable liquid fuel.
- The SUPER•BIO•FUEL™ Burner is not to be installed or used in or on recreation vehicles and / or boats.
- Do NOT use this SUPER•BIO•FUEL™ Burner near automobiles, trucks, vans or recreational vehicles.
- Always use in accordance with all applicable local, state and national codes. Contact your local fire department for details on outdoor / indoor burning. Observe and closely follow burn bans and all associated warnings at all times.
- Use the same precautions you would with any open fire when operating the SUPER•BIO•FUEL™ Burner.
- Do NOT alter the SUPER•BIO•FUEL™ Burner or the Zanzibar Table in any manner.
- Do NOT use / light this SUPER•BIO•FUEL™ Burner until it is COMPLETELY assembled and all parts are securely positioned as specified in this User Manual.
- Do NOT store or operate a liquid propane (LP) gas tank within 20 feet (6.0 Meters) of this SUPER•BIO•FUEL™ Burner / table while it is in operation and or you are about to fuel the SUPER•BIO•FUEL™ Burner.
- Avoid using near or under overhanging trees and shrubs.
- We strongly recommend using SUPER•BIO•FUEL™ Burner on a hard, level, non-combustible surface such as concrete, ceramic tile, rock or stone. An asphalt or blacktop surface may not be acceptable for this purpose.
- Do NOT use this SUPER•BIO•FUEL™ Burner if any part of it contains rain water or other liquid other than specified fuel.
- Do NOT wear flammable or loose long-sleeved clothing when operating this SUPER•BIO•FUEL™ Burner. When operating the SUPER•BIO•FUEL™ Burner / table do NOT wear articles of clothing that contain synthetic fibers (e.g. polyester, nylon, polypropylene etc). In the event of fire becoming uncontrollable and catching light to any part of your body, the synthetic fibers contained in some articles of clothing will melt very fast causing extreme pain and severe burns.
- Make sure you ALWAYS tie back long hair when lighting or extinguishing the SUPER•BIO•FUEL™ Burner.
- Do NOT smoke while setting up, lighting or extinguishing the SUPER•BIO•FUEL™ Burner. Never leave lighters or matches on the table or close to the SUPER•BIO•FUEL™ Burner.
- Do NOT use or operate SUPER•BIO•FUEL™ Burner / table in windy conditions. Sudden and strong wind gusts can cause fire to become uncontrollable, which can lead to a dangerous operating environment and can place you and others at risk. If wind picks up and you notice that the fire appears to be rising uncontrollably above the Ceram fire glass guard, shut the burner down immediately. If safe to do so, close the burner vents and if the fire is out of control, immediately use an ABC or other appropriate fire extinguisher (use fire extinguisher according to manufacturer's instructions) as a last resort.
- Do NOT overfill the SUPER•BIO•FUEL™ Burner with fuel. Using a fuel funnel (supplied with this table and burner) we strongly recommend that you only fill the burner with 1.0 liter of Super•Bio•Fuel™ per burning session. AVOID THE TEMPTATION TO FILL FUEL TO THE TOP OF THE BURNER, THIS IS UNSAFE, UNNECESSARY AND DANGEROUS. Never fill fuel beyond the max fuel reservoir indicator.
- Keep all electrical cords away from a hot outdoor SUPER•BIO•FUEL™ Burner.

DANGERS and WARNINGS: FOR YOUR SAFETY

- Certain areas of this SUPER•BIO•FUEL™ Burner and table when in use will become too hot to safely touch. DO NOT touch any Ceram fire glass guard or burner surface until the burner has been extinguished and allowed to cool down for at least 30 minutes. **WARNING: BE VERY CAREFUL, DO NOT PUT YOURSELF OR OTHERS AT RISK. MONITOR CHILDREN CLOSELY AT ALL TIMES.**
- Do NOT hang or place clothing or other flammable materials on, above or near the SUPER•BIO•FUEL™ Burner.
- Do NOT attempt to move or store this SUPER•BIO•FUEL™ Burner and the table until ALL parts are cool to the touch. Doing so is extremely dangerous and could cause burns or damage to the table.
- Do NOT leave or store any SUPER•BIO•FUEL™ in the burner tank reservoir for any period of time unless you are planning on using the Super SUPER•BIO•FUEL™ Burner within the next 15 minutes.
- For your safety, we strongly recommend that you Do NOT throw or pour anything into the SUPER•BIO•FUEL™ Burner when the unit is in operation / lit or burning. If you wish to re-fuel the burner, wait until the flames have completely extinguished before re-fueling. Only add fuel through the fuel port. When fueling or adding fuel to the SUPER•BIO•FUEL™ Burner, make sure you always wipe up any fuel spills before lighting the burner. If you spill fuel while adding fuel to a lit burner, immediately close the SUPER•BIO•FUEL™ Burner vent / fuel port and when safe to do so, wipe up all fuel spills SUPER•BIO•FUEL™ is water soluble and can be wiped up with a damp paper towel or cloth. A cloth or rag contaminated with SUPER•BIO•FUEL™ should be rinsed out immediately and then placed in your washing machine for regular washing. DO NOT leave contaminated fuel rags lying around in locations where they may be prone to combustion or where pets and or children have access to them.
- Do NOT place yourself, others and property at risk – Always think of SAFETY at ALL times.
- Should the SUPER•BIO•FUEL™ fire become uncontrollable, call the Fire Department / Emergency services. Warn others and evacuate to a safe location. Do NOT put yourself or others in harm's way trying to tackle an out of control fire.
- Do NOT cover or decorate the burner with any items that may hide Warning and caution symbols and messages. It is important that the operator and your friends and family can always see and understand the warning messages on the SUPER•BIO•FUEL™ Burner at ALL TIMES. Keep your burner surface clean so that Warning symbols and messages can be easily read.
- **DO NOT ALLOW OTHERS TO OPERATE THE SUPER•BIO•FUEL™ BURNER UNLESS THEY HAVE READ AND FULLY UNDERSTAND HOW TO SAFELY OPERATE THE SUPER•BIO•FUEL™ BURNER SO AS TO AVOID LOSS OF PROPERTY, SEVERE BURNS AND / OR DEATH.**

SUPER•BIO•FUEL™ can be used indoors (well ventilated spaces) or outdoors. There are no toxic emissions, just water vapor and CO2 like ethanol.

IMPORTANT INFORMATION: NO OTHER FUEL TYPES SHOULD BE USED IN THIS BURNER AS THERE COULD BE RISKS OF INJURY OR DEATH. THIS BURNER IS DESIGNED ONLY TO USE SUPER•BIO•FUEL™

When used outdoors it's important that rain or other liquids do not get into the burner and more importantly, the burning wick. The wick must remain dry at all times (apart from contact with fuel).

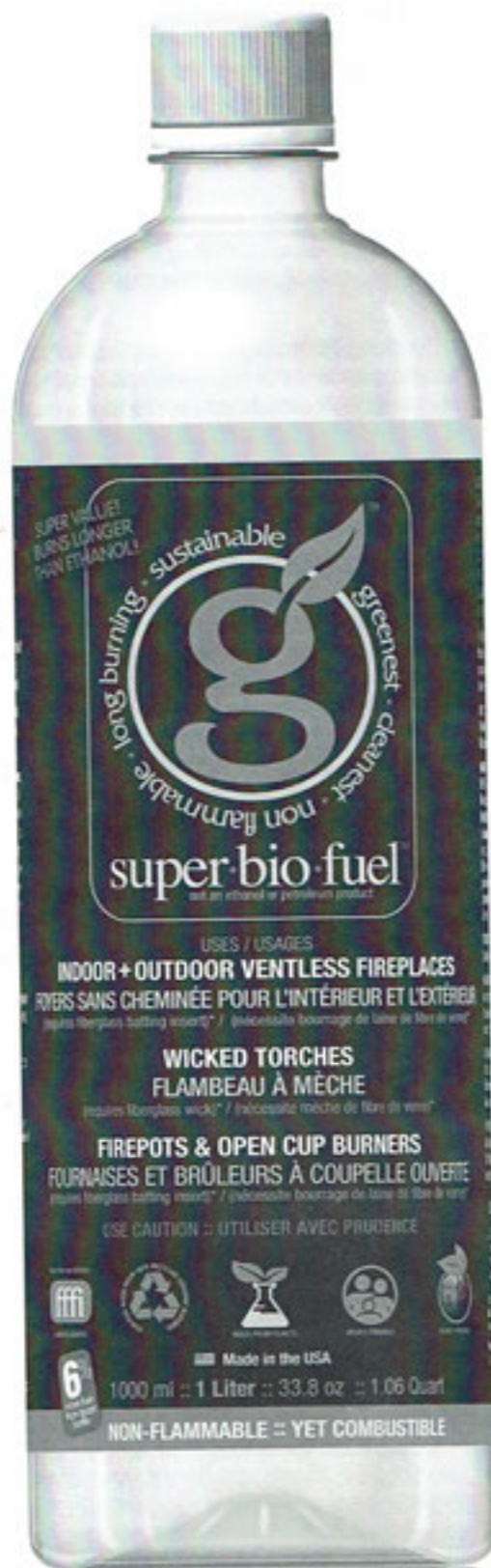
The flash point of SUPER•BIO•FUEL™ is 200° F

Unlike ethanol type fuels, this SUPER•BIO•FUEL™ can be used to re-fill a burner during burning of fuel. The fuel manufacturer recommends re-fueling the burner when you notice that the flames are low and almost at a point of extinguishing. If you allow the burner to completely extinguish, allow for 10 minutes to pass before re-fueling to allow non-toxic gases to escape.

Note SUPER•BIO•FUEL™ does not evaporate like most other fuels or like water. A droplet on the table will remain until it is wiped off or removed. Please be safe with this fuel, wipe up any spills after pouring or fueling the Burner.

Please carefully read the following Material Safety Data Sheet information and read all labels included in this User Manual BEFORE USING OR DISPENSING ANY FUEL. Failure to do so may lead to damage to property, cause explosions, severe burns and or death. Make sure you know and understand how to safely fuel, extinguish SUPER•BIO•FUEL™ at all times and in the event of ingestion or fires becoming uncontrollable, how to seek First Aid / safely extinguish fire from this fuel.

At a minimum keep an up to date and serviced ABC class Fire Extinguisher available and close at hand at all times. At a minimum, **we strongly recommend** that you have an ABC fire extinguisher within 8 feet of the fire.

WHEN REPLACING THE WICK, MAKE SURE THAT YOU INSERT THE WICK WITH THE GRAIN OF THE WICK RUNNING VERTICALLY. CORRECTLY POSITIONING OF THE GRAIN VERTICALLY HELPS THE WICK TO ABSORB THE SUPER•BIO•FUEL™ MORE EFFICIENTLY AND QUICKLY. 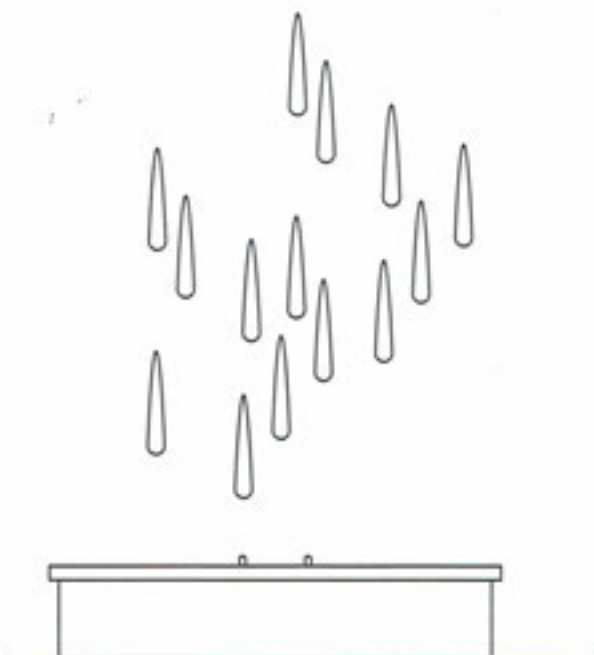

Regular maintenance protects you, others, and your product. Follow these steps to keep your Super•Bio•Fuel™ Burner in good, working order.

Always check all components of your Super•Bio•Fuel™ Burner before you fill it with liquid Super•Bio•Fuel™ or light it.

Do NOT use the Ceram Glass Safety Guard or Super•Bio•Fuel™ Burner if they have any damage, dents, or holes. This could cause fuel leakage. Failure to follow these instructions can lead to uncontrolled fire.

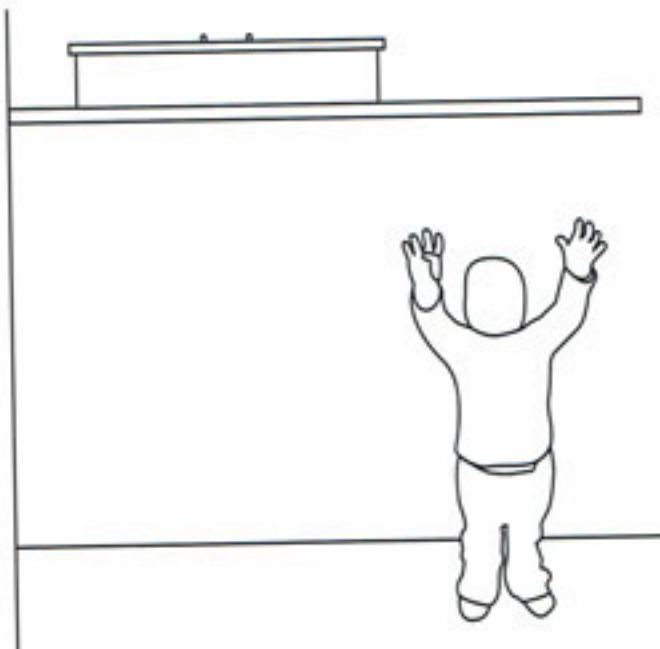
When not using the Super•Bio•Fuel™ Burner, ensure it is clean and empty of Super•Bio•Fuel™. Store it indoors in a safe place along with the Ceram Glass Safety Guard (where none of these products be accessed by children or pets). Keep the stainless steel vent in the Super•Bio•Fuel™ Burner firmly closed to keep dirt and other foreign objects out of the burner.

Regular cleaning will help you to maintain a nice clean stainless steel appearance and also allow family and friends to easily see warnings and warning symbols on the Super•Bio•Fuel™ Burner.

To clean your Super•Bio•Fuel™ Burner:

- Periodically, use a non-abrasive stainless steel cream oven cleaner such as Godard's Oven Cleaner along with a Scotch-Brite® No Scratch sponge pad (and, if required, a small brush to access areas that are difficult to reach) to remove fuel burn brown marks. These products should be available at your local hardware store or online.
- Do not use heavy abrasives and or scrubbing on the etched surfaces. Do not damage the etched warning symbols and or Warning language
- If you see dirt build up inside the Super•Bio•Fuel™ Burner, make sure the burner is cold, then use regular dish washing soap with warm water to carefully rinse it.
- Clean the Ceram Glass Safety Guard regularly with warm soapy water or a glass cleaner that does not have alcohol or another flammable substance.

If you live by the ocean or wish to further protect your table, we recommend that you purchase a table cover or contact your designer or the store from where you purchased this product for table cover options. When not using the Super•Bio•Fuel™ Burner, apply a thin coating of stainless steel protection spray evenly all over it to reduce the chances of rust spotting. Wait until the protection spray has fully dried before using the Super•Bio•Fuel™ Burner again.

Our Perpetual Collection of furniture and planters is designed for full in or outdoor use. Our products are made from a combination of Portland Cement®, special hemp-like grass and natural sands. We do not include any resin and or fiberglass in any of our construction of any of these products. All products in this collection are totally biodegradable.

How to Care For / Your Concrete Product

Please follow these basic steps in assembling and protecting your product:

- 1) Be sure to read all assembly and related information, which is shipped with your product. **DO NOT ASSEMBLE THE PRODUCT IN ANY MANNER OTHER THAN INTENDED BY THE MANUFACTURER.**
- 2) Always seek the assistance of another physically capable adult to assist you in assembling your products. Never try to assemble products on your own, you may hurt yourself and damage / break your product.
- 3) Never use the product in a manner not intended e.g. do not stand, sit or jump on or off any table, doing so may cause injury and harm to you and to others around you as well as damage or break products
- 4) **When you receive your Perpetual Collection merchandise, we recommend that you immediately protect the surfaces of all concrete materials by following these simple instructions. Failure to do so will result in staining of the product and any claim against your product being void.**

Grey Concrete Products:

Remember: Concrete is a porous product and is prone to absorption of oils, fuels, acids and chemicals. Follow these steps to protect your product and maintain a good protective seal

YOU MUST USE EITHER A PRODUCT SUCH AS JOHNSTON'S FLOOR WAX OR OTHER WAX STONE SEALER OR USE THE SEALING SPRAY THAT SEASONAL LIVING CARRIES TO SEAL ALL OUTER SURFACES OF THE CONCRETE MATERIAL. IF YOU FAIL TO DO THIS, YOUR TABLE IS

PRONE TO STAINING AND IS NOT WARRANTED BY OUR MANUFACTURER'S LIMITED WARRANTY

Depending on where and how often you use your Perpetual Collection product, we recommend more regular sealing (especially for outdoor use or heavy soiling from acid based and or oil based foods and liquids at least 3-4 times per year.

For stronger protection, we recommend that you seal the grey concrete with a stone floor wax sealer – apply liberally with a soft non abrasive cloth and working quickly rub the wax into the product. **DO NOT ALLOW THE WAX TO STAY ON, DRY AND HARDEN – THIS MAY DAMAGE THE PATINA OF THE CONCRETE –** We recommend you work in sections, massage the wax in for a quarter or half of the product and then buff it to a nice luster or shine with another clean, soft dry cloth and then continue with the remainder of the product. We then recommend that you leave the product to absorb the wax for at least 4-5 hours. After this time, we recommend you use the sealing spray offered by Seasonal Living and spray or pour a reasonable amount of the sealer on to a cloth and working quickly coat all sides of your product. Allow the merchandise to dry fully for 24 hours before using. Finally, after 24 hours re-apply a light coat of the floor wax and buff to a low shine. Your table will now have a good base of protection but is not totally sealed. See below regarding spills.

For Ivory-White Concrete Products:

Remember: Concrete is a porous product and is prone to absorption of oils, acids and chemicals. Follow these steps to protect your product and maintain a good protective seal

WE RECOMMEND THAT FOR ALL IVORY-WHITE CONCRETE PRODUCTS YOU ONLY USE THE PROTECTIVE SEALING SPRAY PROVIDED BY SEASONAL LIVING AND IF YOU CAN OBTAIN A CLEAR OR CREAM BASED (NO DYES OR COLORS IN THE WAX – THIS MAY STAIN YOUR PERPETUAL CONCRETE MERCHANDISE) WAX FOR APPLICATION TO STONE AND OR CONCRETE SURFACES.

Depending on where and how often you use your Perpetual Collection product, we recommend more regular sealing (especially for outdoor use or heavy soiling from acid based and or oil based foods and liquids at least 3-4 times per year.

For stronger protection, we recommend that you seal the ivory-white concrete with a no dye / color stone floor wax sealer (test this wax on an area that cannot be easily seen to make sure it does not stain the ivory-white concrete patina) – apply liberally with a soft non-abrasive cloth and working quickly rub the wax into the product. **DO NOT ALLOW THE WAX TO STAY ON, DRY AND HARDEN – THIS MAY DAMAGE THE PATINA OF THE CONCRETE –** We recommend you work in sections, massage the wax in for a quarter or half of the product and then buff it to a nice luster or shine with another clean, soft dry cloth and then continue with the

remainder of the product. We then recommend that you leave the product to absorb the wax for at least 4-5 hours. After this time, we recommend you use the sealing spray offered by Seasonal Living and spray or pour a reasonable amount of the sealer on to a cloth and working quickly coat all sides of your product. Allow the merchandise to dry fully for 24 hours before using. Finally, after 24 hours re-apply a light coat of the same floor wax and buff to a low shine. Your table will now have a good base of protection but is not totally sealed. See below regarding spills.

Protect Against Spills and Nature

Because Concrete is a porous product, while your sealing efforts will provide a good barrier, you must still protect your merchandise by being vigilant and we recommend that you follow these steps:

- A) If you spill any type of oil, grease, fuels, staining and or acidic-based juice or sauce (e.g. tomato or other red based sauces, lemon juice, vinegars etc), wipe it up immediately. Do not allow the liquid to remain on the surface of the product. Concrete by its pure nature is a natural product and as such is prone to absorption. Act immediately and you will be able to enjoy your furniture for years.
- B) When not using the product (e.g. furniture) we recommend that you protect the surface by using a professional grade furniture cover. This will help to ward off stains from trees, pollen, bird or other animal urine or fecal matter. Contact Seasonal Living for recommendations on covers.
- C) If you live by the ocean or a salt-water environment, do not allow salt spray to build up on your product. Wipe it off or hose it down on a regular basis. Salt can corrode your concrete product. Remember to regularly seal the product for more protection.
- D) We recommend that you regularly inspect the zinc pan and when you notice rusting starting to occur, we recommend that you purchase from your local hardware store a silver paint such as Rustoleum® or similar spray paint and apply this to the zinc pan in the manner advised by the paint manufacturer. Do not spray the zinc pan while it is in the concrete table top.

Protection From Heat Sources

Never place hot objects such as direct from oven to table cooking dishes directly on top of any Perpetual Collection table or furniture top. Doing so may discolor or cause a heat mark to be impregnated into the furniture's patina. Always use proper heat protection coasters (preferably with a soft cloth or cork base) to prevent heat being transferred directly on to the concrete table top patina.

Perpetual products can be used in an outdoor environment up to a maximum heat of 125 degrees Fahrenheit / 50 degrees Celsius.

Winter Storage

While your concrete merchandise can withstand severe cold (Maximum cold resistance 5 degrees Fahrenheit or minus 15 degrees Celsius), you must follow these steps to further protect your merchandise:

- A) Ideally, we would recommend you be able to move your concrete furniture into a sheltered location. If this is not possible, we recommend that you cover the furniture with a professional grade furniture cover. **DO NOT ALLOW WATER TO BUILD UP BETWEEN THE FURNITURE COVER AND THE CONCRETE SURFACE DURING FREEZING CONDITIONS.** If you cannot purchase a good cover, consider adding a layer of polystyrene foam between the table and your cover. Your goal must be to avoid a wet furniture cover coming into contact with the concrete and freezing. Make sure you do not allow snow and ice to build up on top of the cover if it is touching the furniture – failure to do so, may result in small hairline cracks appearing.

LIMITED MANUFACTURER'S WARRANTY: Ceram Glass Safety Guard
